## SUMMARY

The Founding Partner of the Brazilian boutique law firm ContiCraveiro Advogados, Dr. Mariana Conti Craveiro holds a Ph.D. in Commercial Law and is an expert in commercial arbitration. She is a member of the arbitrator panels of the most important Brazilian arbitral institutions, and has acted as the sole, presiding, and party-appointed arbitrator in numerous arbitrations administered by CAM-CCBC, Camarb, FIESP/CIESP, and CAM-B3.

An expert in Brazilian Corporate and Business Law, particularly with respect to shareholder and corporate law disputes submitted to arbitration, Dr. Mariana also has significant experience with arbitrations involving mergers & acquisition, capital markets, joint ventures, and antitrust issues.

In addition to her practical experience as an arbitrator and advocate, Dr. Mariana's academic interest in international arbitration is manifest and she is a graduate of the ICC's Masterclass for Arbitration (2016) and its Advanced Arbitration Academy for Latin America (2016-2018). Since 2015, Dr. Mariana also has been the head of the Brazilian Committee on Arbitration's (CBar) Study Group on Arbitration and Corporate Law and the Scientific Director in IdiP – Instituto de Direito Privado.

Complementing her Ph.D., magna cum laude, which she obtained from Brazil's prestigious Universidade de São Paulo (USP), Dr. Mariana also holds Master's and Bachelor's Degrees in Commercial Law and Law, respectively, from USP, and she was the recipient of a Scholarship granted by Max-Planck-Institut für ausländisches und internationales Privatrecht (Hamburg, Germany).

Dr. Mariana is a frequent author and lecturer in topics of arbitration and commercial law, and is the author of the recognized corporate law treatise *Shareholders' Agreements— Interpretation and Corporate Law (Contratos entre Sócios—Interpretação e Direito Societário)* (Quartier Latin, 2013).
