

Administrative Resolution No. 02/19

Related to: Arbitration
Ref.: Arbitration Schedule of Costs (2019)

The President of CAMARB – Chamber of Business Mediation and Arbitration – Brazil, in the exercise of his duties, as provided for in the Bylaws, and considering:

- I. that there has been no adjustment in the CAMARB Arbitration Schedule of Costs since 2010;
- II. that an analysis was carried out of the costs charged by the country's main arbitration chambers, with national operations, through which the need to readjust the values charged by CAMARB was identified;
- III. that the CAMARB Board of Directors, in a meeting held on June 3, 2019, approved, in accordance with the Bylaws, a new Arbitration Schedule of Costs (2019);

Resolves that:

- I. the new Arbitration Schedule of Costs (2019) will be applicable to all procedures requested from this date, in accordance with the Rules and the Bylaws of the institution;
- II. The Communications area and the Chamber Secretariat must arrange for the publication of the new Schedule of Costs on the institution's website on this date;
- III. the value of the Arbitration Request Fee increases, from this date, to R\$5.000,00 (five thousand reais) –
- IV. Once the Arbitral Tribunal has been formed or the Sole Arbitrator has been chosen, the parties must deposit the amount of the procedure administrative fee and the arbitrators' fees, and must also advance, for the procedure expenses, the minimum amount of R\$12.000,00 (twelve thousand reais), with each procedural pole being responsible for depositing half of this amount, unless otherwise agreed by the parties.

Notes:

1. If the arbitration is conducted by three or more arbitrators, the fees of each co-arbitrator shall be equal to the reference amount above. The fees due to the President of the Tribunal shall be equal to the reference amount plus 15%.
2. If the arbitration is conducted by a single arbitrator, the amount of fees will be equal to the reference value above, increased by 30%.

3. The administrative fee includes the holding of hearings at CAMARB offices, with the supervision of the Proceedings Secretary. If hearings are held in other locations, the parties must bear and advance the costs of room rental, travel, tickets, accommodation and food incurred by the Proceedings Secretary.
4. If it is necessary for the CAMARB Secretariat to make copies or digitize documents, the costs must be paid in advance and reimbursed by the parties.
5. In the event of a counterclaim, the costs will be calculated considering the sum of the estimated values of the dispute, considering the main pleads and counterclaims.
6. Under the Arbitration Rules, one of the parties may, at its discretion, request the segregation of the estimated value of the dispute, so that each party will bear the administrative fee and arbitrator fees calculated exclusively based on its claims. In the event of failure to pay the respective costs in full by either party, the respective claims will be excluded from the arbitration proceedings, without prejudice to being deducted in a new request for arbitration.
